- **B.** REGISTERED AGENT FOR ENTITIES CREATED IN ALASKA AND UTAH Legally Mine's Registered Agent fees for those not enrolled in this program are \$400 per entity formed in Alaska and \$200 per entity for entities formed in other states each year.
- **C. RENEWAL OF YOUR ENTITY STRUCTURE** Entities must be renewed with the state to remain compliant. We contact you each year to ensure that process is completed. Additionally, we keep track of changes in the law from year to year and will notify you of these changes to keep you protected. We will provide you with an updated blueprint if any changes are needed to your structure.
- **D.** CREATION OF "MEETING AND MINUTES" FOR ALL OF YOUR ENTITIES These are important to keep the protection we create for you valid and up-to-date.
- **E.** ANNUAL TAX STRATEGY REVIEW In order to ensure you save all that you can, we encourage you to speak with a member of our legal team on an annual basis.
